



Personal Information – Notice and Content

Dear Valued Customer

***DAPAT VISTA (M) SDN BHD (“DAPAT”)** which includes the holding company, subsidiaries and any associated company as defined in the Companies Act 1965 (from time to time), places great importance in keeping up with legal and regulatory changes. In view that the **Personal Data Protection Act 2010** is in force, we are taking steps to ensure that we are in compliance with the new Act. We write to keep you informed of our endeavors and also to provide you information on your personal information which we may be processing and the manner in which we are doing so.*

DAPAT processes your personal information, such as your contact details and other information relevant to services with DAPAT which you had previously provided through mobile or website.

Please be informed that your personal information is being processed by DAPAT for the following purposes (“**Purpose**”) and MAY disclose:

- i) To companies and Government organizations for the performance of DAPAT’s contract of providing any goods or services to the customer;
- ii) For profiling of your service preferences;
- iii) To companies and Government organizations for compliance with any legal and/or regulatory obligations to which DAPAT is subject, in addition to any obligations imposed under DAPAT’s contract with the customer;
- iv) To send you information, promotions and updates including marketing and advertising materials in relation to our goods and services and those of organizations selected by DAPAT;
- v) To regulatory bodies or other Government authorities in compliance with requirements under the law towards the detection or prevention of crime and/or fraud;
- vi) To any party involved in or related to a legal proceeding, for purposes of the proceedings;
- vii) To protect DAPAT’s vital interests, for the administration of justice;
- viii) To promote any of DAPAT’s products and/or services, or products, services and special offers of third parties whose products and services we think may be of interest to you; and
- ix) For the exercise of any functions conferred on any person by or under any law.

Your personal information may be disclosed to other companies within DAPAT, its service providers, and DAPAT’s strategic partners, vendors, professional advisers, Governmental agencies and any of their respective agents. Your personal information may also be disclosed or transferred to relevant third parties as a result of any restructuring, sale or acquisition of any company within DAPAT, provided that the recipient uses your personal information for the Purpose only.

Please note that it is necessary for DAPAT to process your personal information for the Purpose, without which DAPAT will not be able to provide the product and/or service that you have requested from DAPAT.

DAPAT does not process any Sensitive Personal Data in its ordinary course of business.

You may request for access to, correction, or deletion of your personal information or limit the processing thereof (including personal data of others provided by you) at any time hereafter.
